## **Note from the Author**

It gives me great pleasure to complete the 29<sup>th</sup> update of Complete Company Law and Procedures Volume-II, 2<sup>nd</sup> Edition. This update covers:

**-SROs: 175(I)/2010, 176(I)/2010 & 591(I)/2010;  
-Anti-Money Laundering Act, 2010.**

These are briefly explained as follows:-

### **Part VA- NBFCs and Notified Entities Regulations**

1. On pages 19 and 20, Regulation 25 has been amended by **SRO 591(I)/2010** dated June 29, 2010. This defers the **Classification and Provisioning for non-performing assets** till July 1, 2012.
2. On page 42, Regulation 55 has been amended by **SRO 591(I)/2010** dated June 29, 2010. This makes amendments in the investment policy and diversification re: **exposure to a single entity**.
3. On page 85, Schedule X has been amended by **SRO 591(I)/2010** dated June 29, 2010. This **extends the applicability till June 30, 2012**.
4. On page 89, Schedule XI has been amended by **SRO 591(I)/2010** dated June 29, 2010. This **extends the applicability till June 30, 2012**.

### **Part VII- Competition Ordinance**

5. On page 55, Regulation 26(2)(a) of the CCP (General Enforcement) Regulations, 2007 has been amended by **SRO 175(I)/2010** dated March 15, 2010. This is re: procedure for **presentation of case** on hearing after submission of Inquiry Report.
6. SRO 05(I)/2008 dated January 02, 2008 appearing on pages 133 to 138 and SRO 999(I)/2008 dated September 19, 2008 appearing on pages 142 to 144 have been deleted having been superseded by **SRO 176(I)/2010** dated March 15, 2010 which has been reproduced on pages 141 to 149. This is re: **Powers and functions of the Members and Officers of the Competition Commission**.

### **Part IX – Anti-Money Laundering**

7. On pages 1 to 32, **Anti-Money Laundering Act, 2010** dated March 27, 2010 has been reproduced in place of the Anti-Money Laundering Ordinance, 2009.
