Note from the Author

It gives me great pleasure to complete the 3rd update of Customs Tariff and Trade Policy. This update covers 2007 SROs 326, 378, 397, 424 to 426 & dated 28th May 2007. These are briefly explained as under:-

Part II – Import Policy

1. On page 37, in Appendix “F” Ozone depleting substances, entry at Serial No. 9 has been amended by **SRO--(I)/2007**, dated May 28, 2007. This disallows import of **Carbon Tetra Chloride** (CTC) with immediate effect and allows import of any ozone friendly alternative solvent substances..
2. On page 70, in Appendix “G” List of items importable from India, a new entry at Serial No. 1077 has been added by **SRO 326(I)/2007**, dated April 18, 2007. This is re: Import of **Halothane**.

Part III – Export Policy

3. On page 8, in Schedule I listing goods not exportable, a new entry at S. No. 14 has been added by **SRO 425(I)/2007**, dated May 24, 2007. This bans export of **Gram**.
4. On page 8, in Schedule II listing goods exportable subject to conditions, entry at S. No. 1 has been amended by **SROs 378(I)/2007**, dated May 09, 2007, **424(I)/2007**, dated May 23, 2007 and **426(I)/2007**, dated May 24, 2007. This is re: export of **wheat**.
5. On page 10, in Schedule II listing goods exportable subject to conditions, a new entry at S. No. 18 has been added by **SRO 397(I)/2007**, dated May 17, 2007. This is re: export of **Mango**.
